(collectively “Energy West”) and the Unsecured Creditors Committee (“UCC”), through counsel, hereby stipulate to continue the hearing presently scheduled on April 15, 2014 on the Request of Energy West for Allowance and Payment of Administrative Expense Claims (Docket #1219), together with the objections thereto filed by

1 the Debtor, the Noteholders and the UCC, until May 20, 2014 on the regular hearings
2 calendar for Billings.

3 The basis for the continuance is that the parties are commencing settlement
4 discussions to resolve the Energy West administrative claim issues and will need extra time
5 for that purpose.
